Issue of Securities

Calima Energy Limited (ASX:CE1) (“**Calima**” or the “**Company**”) is pleased to confirm that it has completed the following allotment of securities:

1. Issue of 2,463,100,509 Shares for the following purposes:
 - a. 2,460,243,360 Shares issued to Shareholders of Blackspur Oil Corp. Details about the Company's acquisition of Blackspur are in the Company's notice of meeting dated 11 March 2021;
 - b. 2,857,149 Shares issued to marketing consultants in lieu of cash payment for such services;
2. Issue of 298,500,000 Executive Employee Incentive Options - This plan has been adapted to meet the norms of Canadian executive option plans and Canadian tax law. The options will vest in 3 equal tranches annually over 3 years, so long as the executive is employed by the Company upon vesting. Further, the option holder will be restricted from converting for a period of 3 months after vesting; and
3. Issue of 20,000,000 Performance Rights - The performance rights will vest following the Company's share price reaching 1.5 cents over 20 consecutive trading days.
